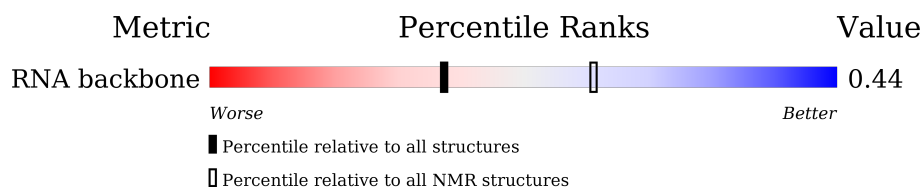
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR


The overall completeness of chemical shifts assignment was not calculated.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

2 Ensemble composition and analysis ⓘ

This entry contains 15 models. The atoms present in the NMR models are not consistent. Some calculations may have failed as a result. All residues are included in the validation scores. This entry does not contain polypeptide chains, therefore identification of well-defined residues and clustering analysis are not possible. All residues are included in the validation scores.

3 Entry composition [i](#)

There is only 1 type of molecule in this entry. The entry contains 768 atoms, of which 262 are hydrogens and 0 are deuteriums.

- Molecule 1 is a RNA chain called 5'-R(*GP*GP*AP*AP*GP*GP*CP*CP*CP*UP*UP*UP*UP*CP*AP*GP*GP*GP*CP*CP*AP*CP*CP*C)-3'.

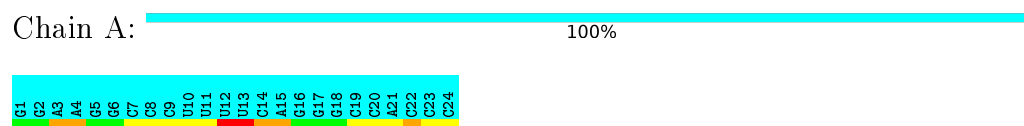

4 Residue-property plots

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

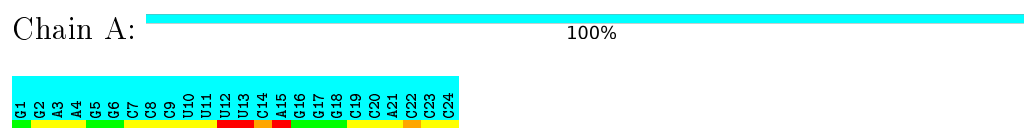

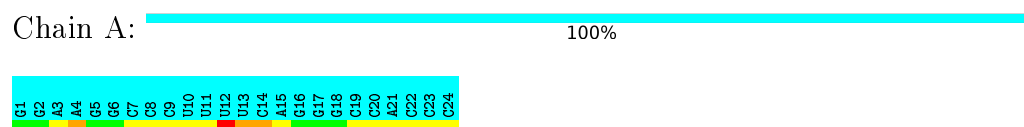

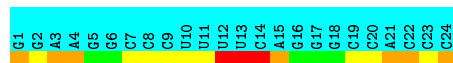

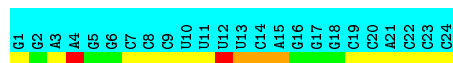

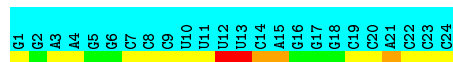

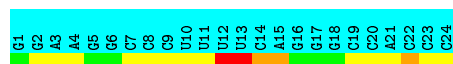

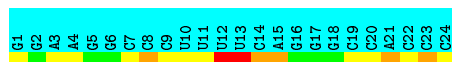

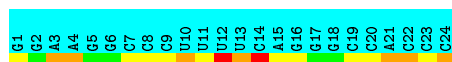

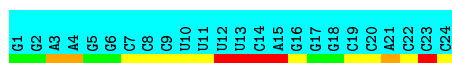

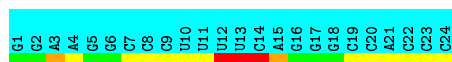

5 Refinement protocol and experimental data overview

The models were refined using the following method: *Molecular Dynamics/Simulated Annealing*.

Of the 100 calculated structures, 15 were deposited, based on the following criterion: *back calculated data agree with experimental NOESY spectrum, structures with acceptable covalent geometry, structures with the least restraint violations, structures with the lowest energy*.

The following table shows the software used for structure solution, optimisation and refinement.
