
1 Overall quality at a glance


The reported resolution of this entry is 2.33 Å.

The red, orange, yellow and green segments on the lower bar indicate the fraction of residues that contain outliers for >=3, 2, 1 and 0 types of geometric quality criteria. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%. The upper red bar (where present) indicates the fraction of residues that have poor fit to the electron density. The numeric value is given above the bar.

2 Entry composition (i)

There are 4 unique types of molecules in this entry. The entry contains 6470 atoms, of which 0 are hydrogens and 0 are deuteriums.






3 Residue-property plots [\(i\)](#)

These plots are drawn for all protein, RNA and DNA chains in the entry. The first graphic for a chain summarises the proportions of errors displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry and electron density. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. A red dot above a residue indicates a poor fit to the electron density ($RSRZ > 2$). Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.

5.1 Standard geometry i

6 Fit of model and data i

6.1 Protein, DNA and RNA chains i

In the following table, the column labelled ‘#RSRZ> 2’ contains the number (and percentage) of RSRZ outliers, followed by percent RSRZ outliers for the chain as percentile scores relative to all X-ray entries and entries of similar resolution. The OWAB column contains the minimum, median, 95th percentile and maximum values of the occupancy-weighted average B-factor per residue.
