
1 Overall quality at a glance ⓘ

The following experimental techniques were used to determine the structure:

X-RAY DIFFRACTION

The reported resolution of this entry is 2.60 Å.

The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the electron density. The numeric value is given above the bar.


3 Residue-property plots [i](#)

These plots are drawn for all protein, RNA and DNA chains in the entry. The first graphic for a chain summarises the proportions of errors displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry and electron density. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. A red dot above a residue indicates a poor fit to the electron density ($RSRZ > 2$). Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.


- Molecule 1: Proteasome subunit alpha type-2




- Molecule 1: Proteasome subunit alpha type-2




- Molecule 2: Proteasome subunit alpha type-3






- Molecule 3: Proteasome subunit alpha type-4






- Molecule 4: Proteasome subunit alpha type-5












- Molecule 6: Probable proteasome subunit alpha type-7









- Molecule 10: Proteasome subunit beta type-4




- Molecule 11: Proteasome subunit beta type-5






- Molecule 12: Proteasome subunit beta type-6






